### JOB SUMMARY

The Angling Trust has an exciting new opportunity to join the Angling Trust Freshwater team, helping to engage the angling community in invasive non-native species management and litter and advance best practice in these areas. There are two Environment Officers; one covering the north of England and the other the south of England. These are newly funded roles available, initially, on 12 month contracts. The job holders will report to and work closely with the AT Environment Manager and will also work with colleagues across AT teams and other relevant stakeholders in delivering our environmental programs.

To deliver the Angling Trust's non-native species work, encouraging the angling community to adopt best biosecurity practice and report and manage invasive species (70%), including:

- Managing the Floating Pennywort Thames Basin Project, which aims to engage relevant stakeholders and anglers in invasive species management to facilitate coordinated, strategic action of the invasive aquatic plant in the Thames region. A key element of this Thames project will be providing training to the angling community on invasive species and to develop best practice guidance on floating pennywort management that can be applied to other areas of the country. The successful applicant will also work closely within the angling community, providing technical advice to fisheries undertaking biosecurity risk assessments at their fisheries, including advice on the installation of wash down biosecurity facilities where these are required. Other aspects of the role will include increasing awareness of priority aquatic invasive species, such as Killer Shrimp, Quagga mussel and other existing and new aquatic invasive species, with targeted communication efforts in areas where these have been found to improve awareness and encourage the uptake of biosecurity measures such as the Check, Clean Dry measures.
- Other aspects of the invasive species role involve providing bespoke technical advice to fisheries undertaking biosecurity risk assessments at their waters, including advice on the installation of wash down biosecurity facilities where these are required.

To deliver the Angling Trust litter program, including engaging anglers in the Anglers Against Litter campaign, and promoting the incorporation of 'reduce, reuse, recycle' approaches into angling activities (30%).

The Angling Trust is the united representative organisation for marine and freshwater angling in England and Wales. It is joined in a collaborative and co-operative relationship with Fish Legal, a separate membership association using the law to protect fish stocks and the rights of its members throughout the UK.

### PRINCIPAL OBJECTIVES AND MAIN DUTIES

The job holder will be responsible for:

#### **Invasive non-native species**

- Provide technical advice to the angling community on how to implement biosecurity measures at angling locations, including assistance in undertaking biosecurity risk assessments and installing wash down facilities. This includes assisting in Angling Improvement Fund applications for biosecurity equipment and wash down facilities where required.
- Engage and educate the angling community on biosecurity and the threat of invasive non-native species
- Promote Invasive Species Week amongst the angling community
- Increase awareness of priority invasive species and encourage increase in biosecurity, and the completion of biosecurity risk assessments in these areas. For the southern region this includes the Killer shrimp following the discovery in Trinity Broad.
- Identify and engage angling communities in the Thames Basin and the South in the Floating Pennywort Strategy. This includes those that fish/ manage priority tributaries but also those within the wider Thames Basin to encourage reporting and the adoption of best biosecurity practice to reduce the potential for Floating Pennywort spread.
- Provide training and advice on how to identify, report, and safely remove Floating pennywort populations in a bio-secure manner.
- Explore and bid for future funding for the GB Floating Pennywort strategy and wider invasive species issues.
- Produce social media content, videos and other educational communication materials to promote the Floating Pennywort Thames Basin project and communicate the issues of invasive species.
- Compile the lessons learnt and best practice developed from the Thames Basin Floating Pennywort project to produce a 'How to Guide' to for manual removal of floating pennywort.

- Engage with, and promote to, the angling community the Anglers Against Litter campaign, including the Take 5 initiative and the Anglers National Line Recycling Scheme (ANLRS).
- Organise or facilitate litter picks by the angling community, producing social media content to cover clean up events.
- Work closely with other relevant stakeholders to promote the 'reduce, re-use, recycle' message within the angling community and incorporate it into angling practice.
- Support the deliverables under the 'Treasure Your River' campaign under HUBBUB which involves the installation of recycling fishing line pipe bins, recycled fishing pegs and engagement activities in several catchments in England, including the Thames.
- Promotion of the Keep Britain Tidy campaign and initiate or organise litter picks during the three-week campaign. This includes production of social media material for regional pages to promote the KBT and collating the information from litter pick events that have occurred in their region.
- Support the INTERREG 'Preventing Plastic Pollution' project, assisting the installation of ANLRS bins and promoting litter picking events in the 4 target catchments in England.
