

## **Neville Fickling**

One event with 12 people in 2017 grew to seven events in 2021 with 100’s of ladies attending.

Although I am no longer the Ladies Carp Team England manager, I will always be committed to raising the profile of angling, growing our sport, highlighting the benefits of being outside in nature, the diversity of angling and its inclusivity.

**Prof. Keith Neal**

I have fished for over 50 years; first sea fishing and introduced to coarse fishing when recruited for the school fishing team in a county wide competition. Fifteen years ago, I started fly fishing whilst continuing my sea fishing. The club also has coarse fishing.

I have significant scientific and political expertise gained over 40 years which would allow me to provide support and oversight in key areas of interest to anglers and the Angling Trust.

We need to encourage more young anglers to take up the fishing and not rely solely on fathers to sons. Linked to this is increasing the number of women and girls who go fishing. This is crucial for the long-term future of the sport. People in inner city areas have limited access to places where they can fish, but usually there is a river through a city. These need cleaning up and access arrangements discussed with clubs that currently have the fishing rights to widen access.

Measures to increase the Angling Trust membership need to be taken given how many anglers there are in the country.

River and sea pollution remains a critical issue. From my research and public health work with enforcement agencies I understand the limitations and barriers to getting this sorted and the knowledge to counter arguments made by the water industry.

Rivers that are good for fishing are good for biodiversity. Anglers are part of the solution. We need to support the campaign against alien species and highlight the lax controls currently in place.

We need to be tougher on commercial fishing quotas, increase habitat reserves and no take policies. Targeting bass spawning grounds is nonsensical. Commercial fishermen are important but the economic impact of tourism around angling is greater. 3 million anglers mean thousands of votes in every constituency.

## **Sean Corbett**

As a career military professional, and latterly in the commercial sector, I believe that I combine all the personal and professional qualities needed to make a difference with the Angling Trust. But above all my unbridled passion for and extensive background in angling in all its forms and love for the natural environment will be of great value. I have been fishing since I was 4 years old and have considerable experience in each of the disciplines.
