## International Angler Code of Conduct 2024

Angling Trust is fully committed to safeguarding and promoting the well-being of all squad Members, Coaching Team and support network. We believe that it is important that Team Members, Coaches and Administrators associated with Angling Trust Team England should, at all times, show respect and understanding for the safety and welfare of others. Therefore, all representatives are encouraged to be open at all times and to share any concerns or complaints that they may have about any aspect of the team with Steve Fitzpatrick, Head of Competitions.

- As an international angler representing Team England, you are expected to abide by the principles outlined within this code of conduct:
- All competitors are ambassadors representing their country and as such will show courtesy and consideration to other competitors, their team, staff and families and everyone that they come into contact with throughout the course of the event.
- All representatives must consider their behavior and conduct while on international duty. Foul language, inappropriate behavior and an improper consumption of drugs or alcohol is not acceptable.
- All Team Members must abide by the rules and respect officials and their decisions.
- All Team Members must respect the rights, dignity and worth of all participants regardless of age, gender, ability, race, cultural background, religious beliefs, or sexual identity.
- All Team members shall not disclose any information that is confidential to the team, such as tactics, strategies, or arrangements, to any other nation's team representative or associates of any other nation who may or may not be taking part in the competition, either verbally or by any form of communication or social media.
- Upon selection to represent Team England, no competitor may represent another nation due to nationality or right of birth for a period of four years from last Team England selection.
- Members should keep to agreed timings for training and competitions or inform their coach or team manager if they are going to be late.

- Members must respect and uphold expectations and obligations where sponsorship agreements are in place.
- Members must abide by the Team Manager/Head of Competitions agreed policy on use of social media prior, during, and following competitions with particular respect given to positive posting when referring to the Team, Management, and AT.
- Members must pay any fees for competitions, events, or training promptly.

Team Members must ensure they are compliant at all times with the <u>World Anti-Doping</u> <u>Agency (WADA) Code</u>, it is your responsibility alone to ensure you are compliant.

Team Members must ensure they are compliant with the Angling Trust Equality, Diversity, and Inclusion policy.

Team Members should be aware of the Angling Trust Whistleblowing policy.

Team Members should be aware of the Angling Trust Safeguarding policies for children and vulnerable adults.

All team members must be an individual member of Angling Trust for the period they are in the team.

Any breach of this code of conduct by any Team Member may result in a disciplinary hearing led by the International Committee (or a Disciplinary Sub Committee) to be attended by the Team Manager and Team Member and parent (if under 18).

The disciplinary committee will have the right to withdraw any Team Members from current and/or future events.
