





# **Angling Trust Individual National Championship Rules 2024**

- 1. The Angling Trust (AT) will organise an Individual National Championship each year. The AT Competitions department will be responsible for supervising the arrangements.
- 2. At the organiser's discretion, the stretches used in this year's Individual National Championship may be closed for practice in the week or days leading up to the event. This will be communicated to all ticket holders.
- 3. The National Championship will be "pegged down" competition, pegs to be preferably 20 yards (18 metres) apart, or more where practicable. And must be a minimum of 30m from overhead power cables.
- 4. The Individual National Championship is open to anyone who has individual membership of the Angling Trust, which is valid on the day of the event.
- 5. No person will be allowed to compete in the event if they are **under the age of 16 on the day of the Championships** unless they have a been issued with an Angling Trust Young Angler Exemption which is valid at the time of the Championship.
- 6. The Draw for pegs will take place on the morning of the event. Time to be specified in the match booklet.
- 7. The Senior Steward will have the right to examine all containers carried by competitors prior to commencement of the Championship, at their pegs.
- 8. Stewards will do their utmost to prevent spectators approaching or interfering with the competitor's swims. Where competitors are drawn on opposite banks, the limit of the swim will be the middle line between either bank and as defined in (a) and/or (b) above. The competitor will restrict their activities completely to these boundaries, neither their person, tackle, bait, ground bait or hooked fish may intrude into their neighbour's swim.
- 9. No competitor will change their section. Any angler fishing at the wrong peg will be disqualified.
- 10. Competitors must use private transport to transfer from HQ to their Section and return.
- 11. Any angler may bring a caddy to help carry their tackle to their peg.

- 12. No competitor will have live or dead fish in their possession before the National.
- 13. The signal to commence and cease fishing will be given by the Senior Section Steward in each Section.
- 14. The duration of the National will be 5 hours.
- 15. Before the starting signal no competitor must on any account ground bait or loose feed the swim but will be allowed to:
  - Wet a line,
  - · Plumb the depth
  - Test the float
  - Mix or wet ground bait
  - Clear their fishing ground of weed or obstructions
  - Position their equipment

#### You cannot:

- Cast a feeder a bomb must be used
- Ship out any form of pot (pole-mounted or cupping kit) over the water
- 16.A competitor may wade provided that the water does not extend above the knees, unless they can touch the bank, in which case the water can extend above the knees. The same principles apply to platforms and knee depth is to be taken at the front of the platform. No Box legs may extend beyond that front of the platform.
- 17. Every competitor must fish from within one metre either side of their designated peg.
  - (a) On flowing water, they will fish from their position in the direction of the flow as far as the next peg.
  - (b) On still waters they may fish as far as half the distance between their peg and the pegs on either side.

In an extreme situation, e.g. snagged tackle or a snagged fish, an angler must seek permission from their neighbour/neighbours before moving from their designated peg to try and remedy the situation.

18. No competitor may leave their peg during the Championship other than to go to the toilet. However, in the event of an emergency and/or severe weather conditions, a competitor may leave their peg, but only with the express permission of the Senior Section Steward.

In such circumstances, the Senior Steward may decide in the best interests of the competitors that fishing should be suspended.

- In the worst case fishing may be terminated by the Senior Steward upon an instruction from the AT's team of Championship adjudicators.
- 19.A competitor shall have in use one rod or pole, one line, and single hook at any one time, but may have other poles or rods and tackle assembled in a position behind them, if possible, providing no such other tackle is baited.
- 20. Maximum Length of Poles, 16 metres, Floating poles are not permitted.
- 21. Braid hook lengths are not permitted.
- 22. Any bait, subject to the local rules appertaining at the time of acceptance as a National Championship venue, may be used during the National Championship, except live or dead fish, spinning baits and artificial lures.
- 23. Surface floating baits, either hook or feed are not allowed.
- 24. The use of electronic fish finders is forbidden.
- 25. No competitor shall present their baited hooks into their swim by any means other than the pole or rod to which the line is attached.
- 26. All feed may be thrown in by hand, or by the use of one or two-handed catapults, throwing sticks, swim feeders, bait droppers, bait cups and bait shuttles, but no other mechanical means of projecting feed is allowed. No bait shall be introduced with a pole or bait dropper attached to an extra pole or rod whilst continuing to fish. Spodding is not permitted.
- 27. Competitors must strike, play and land their own fish from the confines of their own peg. (See Rule 17). Hand lining fish is not permitted; this includes hand lining elastics and line. Also, not allowed is the practice of trapping stretched elastic with the hand down the length of the pole, fish should never be bullied like this. This does not affect the use of Pulla bungs and similar devices.
- 28. Competitors must retain all fish in a keepnet that complies with the relevant Environment Agency byelaws: <a href="https://www.gov.uk/guidance/national-rod-fishing-byelaws-for-england-freshwater-fishing-with-a-rod-and-line">https://www.gov.uk/guidance/national-rod-fishing-byelaws-for-england-freshwater-fishing-with-a-rod-and-line</a>
- 29.All Keepnets must be laid out on the bank before the start. Keepnets will only be allowed to be put into the water 15 minutes before the all-in.
- 30.2 keepnets are not a requirement for the 2024 Individual National, but we ask that anglers are sensible and consider taking/ using a second keepnet where

- appropriate. Competitors must lay ALL keepnets out on the bank before the start, as per rule 29.
- 31. All fish caught are eligible for weighing except Game Fish (salmonids, including grayling) & Pike. Crustaceans (e.g crayfish) are not fish and do not count.
- 32. Competitors must, if practicable, keep all fish caught alive. If for any reason competitors cannot keep fish alive, the Stewards shall have the power to weigh in during the Championship and return the fish alive to the water.
- 33. Competitors must cease fishing at the signal. Should a competitor still be playing a fish hooked before the finishing signal is given, they will be permitted no more than 15 minutes after time has been called to land the fish. All competitors will remain at their pegs, except for the purpose of clearing litter from their swims, or, for reasons (as defined in Rules 17 and 18), until details of their catch have been recorded by the Steward, even if they have caught no fish.
- 34. Competitors are responsible for ensuring their pegs are clear of litter and no competitor shall have their catch weighed in who has litter on the banks of their swim.
- 35. Both the competitor and steward(s) must ensure that the correct procedure is used for transferring fish from a keepnet to a weigh net. They MUST utilise either,
- a. pulling a lower ring through and pouring fish into the weighing net or
- swimming them up the keepnet and pouring.
- 36. The individual weight of each competitor will be recorded to the lowest possible denomination on the scales provided in Kilograms.
- 37. After each competitor, has been weighed in at their peg and signed for, all fish must be carefully and considerately returned to the water.
- 38. Competitors must, if practicable, keep all fish caught alive. If for any reason competitors cannot keep fish alive the Stewards shall have the power to weigh in during the competition and return the fish alive to the water.
- 39. Any dead fish should be weighed and recorded separately; the steward will clearly mark this on the weigh sheet. The decision as to whether the dead fish will be added to the weight of the anglers catch will be at the discretion of the AT Competitions Team.
- 40. All competitors must conform to Environment Agency byelaws. Any competitor reported to the Event Management Team by the Environment Agency for being unable to produce a valid license shall be deemed to be in contravention of the Rules and shall be disqualified. All pools, entry fees etc. in respect of the said competitor shall be forfeited.

- 41. Any Challenge must be made in writing and lodged with a member of the AT Competitions Team or Senior Section Steward no later than one hour after the end of the match and before the results are published. Irregularities which are brought to notice at a later date may be dealt with only by and at the discretion of the AT Competitions Team.
- 42. If in the opinion of the AT Competitions Team, any Team or Individual is in breach of these rules or is guilty of behaviour which is contrary to the best interests of the sport, or upon complaint being received by the AT Competitions Team that there has been an alleged breach of the rules, the AT Competitions Team shall make a decision on all available facts and that decision will be final and binding.
- 43. Any team or competitor proved to be in contravention of these rules will be disqualified

# **Biosecurity for Competitors**

Please help prevent the spread of invasive non-native species (INNS), diseases & parasites by practicing good biosecurity in the build up to this year's National. All anglers should follow the mantra of *Check, Clean, Dry* after every match or practice session.

#### What is biosecurity?

Biosecurity is about the measures we take to prevent the spread of unwanted plants, animals and diseases between waters. The things we could potentially transfer are wide ranging, but some common examples you might be familiar with include:


- Koi herpesvirus (KHV) viral disease
- Floating Pennywort invasive aquatic plant
- Signal Crayfish invasive aquatic animal
- Himalayan Balsam invasive terrestrial plant

### Why is biosecurity important?

### Invasive non-native species, diseases & parasites affect your fishing.

Match venues can be devastated by the arrival of invasive species or disease; whether it's a viral outbreak that kills fish, or plant growth that makes a stretch of water unfishable.

Invasive non-native species *are present* in and around the Leeds & Liverpool Canal, which are currently being managed. Please respect our host club and your own waters by following the guidance on the next page.



### How do I practice good biosecurity?

Biosecurity is simple when carried out by following Check, Clean, Dry. You should pay particular attention to:

- Keepnets & landing nets which should be clean and completely dry before they are submerged. (Note rule 29 RE keepnets)
- Stink bags which should arrive at a venue dry. You should not under any circumstances bring your nets to a new venue in a wet/ damp stink bag which hasn't been dried or cleaned.
- Footwear invasive terrestrial plants such as Himalayan Balsam can be easily spread by their seeds, which could be carried in the mud on your boots.



Team captains should ensure that all squad members are briefed on the above.

## **Practice Opportunities**

Day tickets are not available on the Wigan & District Angling Association stretches of the Leeds & Liverpool Canal, but match lineups can be booked at £5 per peg (minimum of 5 anglers) via Lead Organiser Trevor Smith (<a href="mailto:trevorsmithy@blueyonder.co.uk">trevorsmithy@blueyonder.co.uk</a> or 07906846226). The club ask that this is done in advance to prevent areas from being overfished.

The Club also run members only matches on Wednesdays, Saturdays and Sundays. Individual membership costs £45 for adults and £27 for over 65s. Any anglers fishing the flyers will have the opportunity to qualify for the annual 'King of the Cut' match which guarantees a minimum of £2000 to the winner.
